### Report of Board of Trustees Chair by Dr. Susan Schneibel:

- Susan S. discussed the Maryville City Council Workshop she attended on Friday, 21 February.
  Susan shared the report she presented at the workshop and answered questions from the board.
- The Blount County Commission approved the Inter-Local Agreement at the 20 February commission meeting.
- The Maryville City Council will vote on the agreement at the 6 March council meeting.
- A discussion on the Evergreen Study was deferred to a future meeting.

# Report of Blount County Public Library Director by K.C. Williams:

- The February 2020 Board Meeting Packet, which includes the Financial Report, the 2019-20 Library Use Statistics, and the 2020-2021 BCPL Proposed Budget was distributed by email prior to the board meeting.
- K.C. and Anjanae answered questions from the board regarding the Financial Report.
- K.C. and Ari Baker will be presenting on the OCLC Grant at the Public Library Association conference in Nashville on Thursday, 27 February.
- Logan Hill requested data on the number of library patrons in municipalities other than Maryville and Alcoa in the county.

# Report of Foundation Board, Angela Quick

- Angela Quick reported the Foundation board did not meet in February because the library was closed due to area flooding on 7 February.
- The Security Camera System proposal will come to the Foundation board at the 6 March meeting.

# Report of Friends of the Library, Dick Burgess

- Dick Burgess mentioned the Little Free Library that was recently installed outside the library on the Greenbelt-side of the building has gotten a lot of positive feedback.
- The next book sale is scheduled for 5-7 March.
- Steve Ross and Dana Jester from the TV show "Joy of Painting" will offer art classes at the library Thursday, 5 March through Saturday, 7 March. They will give a seated lecture in the Main Gallery on Thursday evening at 6 pm.
- Additional speakers have been purchased for the Main Gallery sound system.
- The Friends board will consider a proposal to purchase an additional lapel microphone for the Main Gallery sound system.
- The Friends board wants to consider having an outdoor market for Artists and Crafters on the library grounds. A proposal will be presented to the Library Board of Trustees. Lisa Misosky answered questions from the board about the plans for the market.

#### Report of Ocoee River Regional Library, Liz Schreck or representative

- The READS FY 2019-20 Data Statistics were distributed by email prior to the meeting.
- Liz Schreck distributed the Ocoee River Regional Library February 2020 Report.
- Liz mentioned Blount County Public Library is second in the state in READS circulation.
- Liz discussed the upcoming training opportunities.
- The 2020 TLA Conference will be in Knoxville 31 March 2 April 2020.
- The 2020 Census will be available online. Public libraries will play an important role in providing computers and internet access to the public.
