Blount County Court System to include Justice Center and Court House

During this period of suspension any court filing **shall be** lodged with the appropriate court clerk's office by use of the drop box, email or fax. Attorneys and litigants **shall** use these methods to file rather than filing in person. Likewise, any document that needs to be delivered or presented to any judge or clerk's office **shall be** delivered or presented by use of the drop box, email or fax. Such documents include but are not limited to violation warrants. If any filing or document relates to an emergency and requires an immediate signature from a judge, arrangements **shall be** made by contacting the judge's office or the appropriate clerk's office in advance of bringing any such filing or document to the Justice Center or Courthouse.
